## ASSESSMENTS AND SCREENINGS

The first step in accessing services at Fountain Centers is to complete a screening or a chemical use assessment to determine the appropriate service.

***Chemical Use Screening:*** A chemical use screening will be conducted per a request by a concerned person whether it is in regards to their own chemical use or a family member seeking to identify available resources. This brief screening includes a 15-20 minute face-to-face or telephone interview and a discussion of recommendations. The outcome of this interview does not include a diagnosis or a written report. Due to the brevity of the chemical use screening, there is no charge and a full assessment will need to be completed to arrange for admission into treatment.

***Chemical Use Assessment:*** A chemical use assessment entails a face-to-face interview with a qualified professional. Lasting from 1-2 hours, the chemical use assessment will result in specific recommendations, a diagnosis (or no diagnosis if the person does not meet the criteria) and education to the individual regarding the “next step”. Should the individual demonstrate an interest and qualify for treatment, the counselor completing this assessment will aid the individual in arranging admission to an appropriate program. An assessment summary, which includes a brief description of the individual’s bio-psycho-social history, chemical use history, collateral information, diagnosis and recommendations, will be provided to the referral source and the individual upon request and payment for the service. There is a cost for this assessment.

***Rule 25 Assessment:*** All Minnesota residents age 17 and younger qualify for this type of an assessment to determine the level of care needed for treatment. Minnesota residents age 18 and older may qualify based on their income. This assessment is completed through the county of residence and the county’s Rule 25 assessor or an approved provider. Most often, an individual seeks this type of an assessment when they do not have health insurance or lack financial assistance to pay for treatment. The county assessor will assist with placing the individual in an appropriate treatment facility.
