# **Facilitated Dialogue**

The Facilitated Dialogue is a structured monthly meeting between MCHS and the City of Albert Lea. Members including MCHS Regional Chair Eric Crockett and MCHS – Albert Lea and Austin Administrator Kris Johnson and City of Albert Lea Administrator Chad Adams came together in December to thank Judge David Minge for his leadership of the meetings over the last year. It was agreed that Judge Minge's service as regular facilitator is no longer needed to ensure productive and constructive meetings going forward.

The Facilitated Dialogue has helped advance initiatives and created an open environment to discuss issues of common interest. Accomplishments stemming from the work of the Facilitated Dialogue include

- Clear message on how to access health care services available in Freeborn County (mailing and magnet)
- Ambulance service from Albert Lea to Austin medical center for patients needing hospitalization at no charge to the patient
- The opening of the new Psychiatric Services Unit (PSU) in Albert lea; the Open House featured many community partners who provide additional resources for mental health

- MCHS has added resources dedicated to community engagement in Albert Lea
- Mayo continues to invest resources in recruitment of providers and staff.

At the December meeting, Garry Hart of SMART Transit and Ellen Kehr of the Community Engagement subgroup both provided updates (see below) and the attendees were able to recognize Judge Minge for his contributions to the community. MCHS leaders and the City of Albert Lea will continue to meet on a regular basis without the assistance of a formal facilitator.

## MCHS - Albert Lea and Austin

Many outpatient services are available in Albert Lea; most notably, the Emergency Department remains open to serve the community. Work continues in Austin to renovate and expand the Intensive Care Unit, Medical/Surgical inpatient hospitalization unit and the Family Birth Center with improved amenities. Renderings of the plans will be available to view on both campuses in the coming weeks.

# **Patient Voice Project**

The Patient Voice project, a collaboration with The Patient Revolution, attempts to better understand the challenges related to access from the patient and community perspective. Through interviews and workshop activities, one of the key insights to emerge is that the rules of the clinic and hospital can leave people feeling unseen and unheard. In January, The Patient Voice Project will embark on a series of experiments with care teams on both campuses of MCHS Albert Lea and Austin to identify some strategies to make systems more flexible and responsive to patient situations. If you seek care at the clinic in the coming months, you may encounter our experiments. We welcome your feedback and ideas as we work together to develop better systems of care. # **Alden and Kiester Clinics**

As we indicated in early October 2018, a number of staff changes created vacancies in two of our smaller clinics in Southeast Minnesota. We announced a plan to reduce service to one day a week from November through December, after which time there would not be a prescribing provider on site in Alden or Kiester.

We used the transition period from November through December to work with our communities of Alden and Kiester to understand residents' needs and discuss alternative solutions for care, such as the Nurse Care Line and Patient Online Services, which includes Express Care Online. After much deliberation, we have made the difficult decision to close both of these clinics as of Friday, Jan. 25, 2019. We will have staff available at the Kiester clinic on Tuesdays through Jan. 22, and at the Alden clinic on Fridays through Jan. 25, to help patients transfer their care to other locations and to provide education on other care options, such as our 24-hour nurse line and Express Care Online.

This decision was not made lightly. We listened to community concerns and looked for options to pursue. We remain committed to serving our patients and communities throughout our region. We will continue to engage in discussions to find innovative ways to meet the increasing demand of patient care close to home for rural communities.
